DINGHY STORAGE AGREEMENT – REGULAR SEASON

By signing below, I acknowledge and agree to the following terms and conditions of regular season storage for my rowing or outboard-powered DINGHY (“Dinghy”) at Edgewood Yacht Club (“EYC”):

- The regular season storage period commences on May 1 of each year and extends through October 31 of the same year (the “Regular Season Storage Period”). Dinghies located on EYC premises outside the Regular Season Storage Period may be removed from or within the EYC premises by EYC without further notice to the owner, unless arrangements have been made by the owner with EYC for storage of the Dinghies outside the Regular Season Storage Period. Dinghies do not include small sailboats (except for convertible rowing dinghies).
- All Dinghies will be assigned a space on the dinghy docks. While not in use, all Dinghies will be stored only in the assigned space during the Regular Season Storage Period. Dinghies located elsewhere during the Regular Season Storage Period may be moved by EYC without further notice to the owner.
- All Dinghies stored at EYC during each Regular Season Storage Period must have this form properly completed and signed and their Regular Season Storage Fees (defined below) paid in full on or before the later of (a) May 1 of the applicable Regular Season Storage Period (or such later date that the Dinghy is first stored at EYC), and (b) if the owner is an EYC member and has elected below to be billed for the Regular Season Storage Fees, the due date of the first bill on which such fees are included. Dinghies for which this form has not been properly completed and signed or for which their Regular Season Storage Fees have not been paid as set forth in this paragraph may be removed by EYC from or within the EYC premises without further notice to the owner.
- Regular Season Storage Fees (2019) are as follows for each Dinghy: (a) \$90 for one Dinghy per larger boat with a paid slip or mooring; (b) \$175 for Full Members (other than Dinghies qualifying under clause (a)); and (c) \$350 for Dry Storage Members (maximum one Dinghy per Dry Storage Membership).
- All Dinghies must be marked with the owner’s name and phone number.
- I acknowledge and agree that the storage of my Dinghy or Dinghies at EYC will subject my Dinghy or Dinghies to potential damage from weather and other causes, and I release EYC and its governors, officers, employees, agents, and representatives from any and all claims related to my Dinghy or Dinghies, whether caused by EYC or its agents or otherwise.
